Your Application for Review of a Freedom of Information Decision

Your application requesting a review of the freedom of information (**FOI**) decision made by Mount Buller & Mount Stirling Alpine Resort Management Board was received by the office of the Freedom of Information Commissioner (**FOI Commissioner**) on 26 December 2015.

An initial assessment of your application is being undertaken and a member of the office of the FOI Commissioner will be in further contact with you shortly using the details you have provided.

If a decision has not been made on your application within 30 days of receipt, then a decision to refuse access is deemed under the *Freedom of Information Act* 1982 (**the FOI Act**) to have been made. This gives you the right to apply to the Victorian Civil and Administrative Tribunal (**VCAT**) for a review of that deemed decision. If you prefer the FOI Commissioner to make a decision on your application, then you may agree in writing to extend the time within which the decision must be made. If the FOI Commissioner's decision is not to release all documents to you, then you have a right to seek a review of that decision by the VCAT.

## Written Submission

Section 49H of the FOI Act requires the FOI Commissioner to give each party the opportunity to make a written submission regarding the review.

A written submission may provide any information you believe is relevant to the review, including an explanation of why you believe the documents do not fall under the exemptions applied by the agency, or why you believe the documents should be released regardless of the exemptions that may apply.

Alternatively, you may decide that your written application for review constitutes your written submission.
